Invitation for Bids for the **Development of small AFS at Tulsipur Airport**

1. Nepal Oil Corporation Limited (NOC) *has allocated funds* from towards the cost of development of small AFS at Tulsipur airport, Lumbini province. Bidding is open to all eligible as per Section V of bidding document.
2. **Nepal Oil Corporation Limited (NOC)** invites electronic bids from eligible bidders for the construction of **small AFS** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 3.74 crore**
- Minimum Work experience of similar size and nature:
 - ***Bidder shall have successfully Completed, at least 1 (one) project of value at least NRs. 2.00 crore in the last 10 (ten) years, prior to the applications submission deadline.***
- Must have Following Key Activities:
 - a) RCC work > 222 m³
 - b) EPS Sandwich Panel > 124 m²
 - c) Rectangular Interlock Concrete Block Paver (multi colour) with Compressive Strength M35 > 241 m²
 - d) Fencing work > 217 m²
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

For the purpose of Bidders to submit their bid electronically through E-procurement section of PPMO's Web Site <http://www.bolpatra.gov.np>., the Bidders may download the bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. Bidder to download and submit bid electronically, the bidder shall be required to deposit the cost of bidding document **NRs. 5000 (Rupees Five Thousand only)** in the Employer's Rajaswa (revenue) account as specified below and scanned copy (PDF format) of the Bank deposit voucher shall also be submitted along with the electronic submission of the bid files.

6. Pre-bid meeting shall be held at ***Nepal Oil Corporation (NOC) Limited, Central Office, Babarmahal, Kathmandu, Nepal*** at **2078-01-30**.
7. Electronic bids must be submitted to the office ***Nepal Oil Corporation Limited (NOC), Babarmahal, Kathmandu, Nepal*** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 2078-02-09**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 2078-02-09** at the office of ***Nepal Oil Corporation (NOC) Limited, Central Office, Babarmahal, Kathmandu, Nepal***. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 6.24 Lakhs**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
